JUROR

The juror for the 2014 show is a noted Virginia watercolor artist of national reputation. **Susan M. Stuller** is a signature member of the National Watercolor Society, Transparent Watercolor Society of America, Watercolor West, San Diego Watercolor Society, Southern Watercolor Society and many others. Her paintings have been published in Splash 10, 11, 14 and Splash Retrospective: A look back at the best of 20 years of Splash as well as Artistic Touch 5 and 6. Susan has a featured artist article in December 2013 Watercolor Artist Magazine. She currently teaches painting classes in Richmond and has been an exhibiting artist for over 30 years. ELIGIBLE ARTISTS

Virginia residents age 18 or older

ENTRY FEES

- CVWG Members.....\$25
- Non-Members.....\$35
- Entry fee plus CVWG membership.....\$60

Note: A handling fee of \$25 will be charged for accepted works not delivered by hand.

ELIGIBLE WORKS

- Only works completed since 1/1/2009
- Acceptable water media: watercolor, acrylic, casein, gouache. Ink, watercolor crayons; graphite may be present but must not dominate. (No water soluble oil or pastel products.)
- Acceptable substrates: natural or synthetic paper, paperboard
- Collage elements permissible if created by the artist in compliance with acceptable water media and substrate requirements. Less than 10-15% acceptable.
- No reproductions or works that were juried into a previous CVWG annual show will be accepted.
- Works must be original in concept and execution, conceived and created without the direction of an instructor. Photo references must be the property of the artist.
- Artists may submit up to two works but only one is eligible to be juried in.
- All works must be under cover (acrylic glazing/Plexiglas only) and matted in white or light color and ready to hang.

FRAMING

- Simple wood or metal frames with screw eyes or eyelet hangers placed 4 inches from the top
 - Plexiglas only, no glass
 - Maximum framed dimension not exceeding 44" x 44" or smaller than 16" X 13 "
- Poorly matted or framed paintings are subject to disqualification.

ENTRY PROCEDURE

Submission Deadline: June 7, 2014.

Images must be saved in .jpeg format and emailed to Registrar.

Checks, (sorry, no on-line payments) must be snail-mailed to Registrar.

Artists will receive an email from Registrar confirming receipt of images and entry information by June 11. Notification of acceptance will be emailed by July 25.
